Digital therapeutics are growing in variety and importance in healthcare. Ann will provide attendees with a background on digital therapeutics, specifically those that combine drugs, devices, and technology to improve patient health. The FDA's proposed framework for "Prescription Drug-Use-Related Software" provides insight into how the FDA may approach digital therapeutics in the future, and the FDA has already received stakeholder perspectives on the proposed framework. A major area for FDA consideration is the impact of digital therapeutics on drug compendia listings, as compendia impact electronic health records, pharmacy management systems, and payer adjudication systems. For pharmacists, digital therapeutics may provide benefits that enhance patient care. Ann will discuss opportunities for adherence initiatives, data available from digital therapeutics, the role that pharmacists can play, and opportunities for pharmacist compensation.

10:45 – 11:30 Implementing Digital Health in Pharmacy: Lessons from the AMA

Brent Fox, Pharm.D., Ph.D., Associate Professor, Auburn University Harrison School of Pharmacy

Pharmacists and their technology vendor partners are faced with an expanding menu of IT innovations that promise to bring meaningful change in both the pharmacist's workflow and the patient's experience. While the hype accompanying some innovations does come to fruition, many innovations simply do not pan out. Among today's healthcare innovations, digital health is one of those innovations receiving considerable hype. Defined as "the cultural transformation of how disruptive technologies that provide digital and objective data accessible to both caregivers and patients leads to an equal level doctor-patient relationship with shared decision-making and the democratization of care," digital health is enabled by the proliferation of consumer electronics and the ongoing transformation of the patient's role as an active partner in his or her own care. Recognizing the challenges of implementing digital health and other IT innovations in medical practices, the American Medical Association developed a guide for digital health integration. Brent will highlight the AMA guide, focusing on principles and applications for pharmacy.

The Mayflower is listed on the National Register of Historic Places and has enjoyed a reputation as one of D.C.'s most



noteworthy addresses since 1925. It's been called the "Grande Dame of Washington," the "Hotel of Presidents," and was referred to as the city's "second-best

address" by President Harry S. Truman. The hotel is two blocks from Farragut Square and close to many of

Washington's attractions, including the White House, the National Mall, and the museums of the Smithsonian. EDGAR, The Mayflower's signature restaurant, offers a brasserie-style environment. The hotel also has a 24-hour fitness center with modern equipment.

GROUND TRANSPORTATION

The Mayflower is five miles from Ronald Reagan Washington National Airport (DCA), with an estimated taxi fare of \$23, one way; 27 miles from Washington Dulles International Airport (IAD), with an estimated taxi fare of \$85, one way; and 36 miles from Baltimore/Washington International Thurgood Marshall Airport (BWI), with an estimated taxi fare of \$70, one way. You can also use the Washington Metro. The Farragut North (Red Line) stop is 0.1 miles from the hotel and the Farragut West (Blue, Orange and Silver Lines) stop is 0.2 miles from the hotel. The Mayflower does not provide shuttle service.
